4. Approval of Minutes from June 15, 2015 RCC Meeting – Draft minutes are included in the packet.

5. New Business

5.a. Updates to Fitchburg’s Park & Open Space Plan – Scott Endl (Fitchburg’s Parks Director) and Wade Thompson (Fitchburg’s Community Planner) will be providing an overview on the proposed process for updating Fitchburg’s Park & Open Space Plan and would like feedback from RCC members on this process.

6. Unfinished Business

6.a. MG&E’s Charge to Fitchburg for Street Lamps Electricity – LED Lights – MGE determines unmetered monthly cost based on type of light, wattage, hours of operation, and a set maintenance fee.

Holly Powell is planning to study various LED lamps used in other municipalities (Madison and Monona) and perhaps install some other options for study in Fitchburg. She reports that residents are very resistant to the change in lighting conditions when the switch is made to LED, and she would like to find the best fixture possible to meet energy, safety and aesthetic needs. She is also planning to

do an inventory of all Fitchburg street lights in 2016 to identify 1) the number of lights 2) the type of light fixture and 3) ownership (MGE, Alliant, City of Fitchburg). This will help us evaluate strategies for converting fixtures to LED as the fixture prices decrease and new incentive opportunities arise.

6.c. Eco-Municipality discussion – Chris will lead a discussion on this topic.

6.d. Review/Provide Recommendations for 2016 RCC Operating Budget Requests
– Diane was able to compile a spreadsheet (included in the packet) showing past RCC requests, past approved budgets, and initial suggestions from RCC members for 2016.

6.e. Retrocommissioning Update – Samuel/Erika – Please see the June 23, 2015 staff memo from Erika included in the packet.

6.f. Community Outreach Subcommittee – Boys & Girls Club Summer Event – July 30, 1-2:30pm – Chris and Erika will provide an update during the meeting and seek feedback from RCC members.

8. Staff Update

8.a. Solid Waste Update – The Organics Collection Subcommittee (Jan, Tony, and Rick) had a conference call with Duane Toenges and Dan Meccariello (Dynamic Group) on July 8th to discuss Dynamic Group's interest in working with Madison, Fitchburg, and other local municipalities to set up an anaerobic digester in the Dane County area that could process source separated organics.

8.b. Stormwater Update – The City received notice that the Yahara WINs Executive Committee authorized stormwater grants to Fitchburg as follows:

1. Lacy Heights Bioretention Facility - \$10,500
2. Schumann Greenway Restoration/McKee Farms Northwest Pond Enlargement - \$15,000

We also received word on July 14th that the grant application for project #2 above to the National Fish & Wildlife Foundation was unsuccessful. We also have a grant application to DNR for project #1 above that we hope to hear back from DNR this September or October.

The new Natural Resources Conservation Service (NRCS) rainfall depths and distributions took effect throughout Wisconsin on April 1, 2015. We've updated our Erosion Control & Stormwater Management (ECSWM) Requirements web page (<http://www.fitchburgwi.gov/231/ECSWM-Requirements>) and have been requiring that all ECSWM permit applications submitted after April 1, 2015 use the updated rainfall depths and distributions. We anticipate updating this information in Chapter 30, Article II of Fitchburg's Municipal Code as soon as we get confirmation from

Dane County and the State that they are done making changes to their respective county and state performance standards.

8.c. Sustainability Update – MGE is kicking off community conversations to engage customers and communities in meaningful discussions about the challenges and opportunities in building MGE’s community energy company of the future. There was an article about these community conversations in yesterday’s *Wisconsin State Journal*: http://host.madison.com/wsj/business/mge-to-start-community-conversations/article_868fd26d-3ff4-567d-85e8-f623ce9a4455.html

A link to the Discussion Guide MGE developed with assistance from the Great Plains Institute for the conversations is available online at (<http://www.mge.com/images/pdf/cec/cecguide.pdf>) and printed copies are also available.

MGE plans to use the feedback from these conversations, along with input from partner organizations, such as the Citizens Utility Board and Clean Wisconsin, to inform their future energy plan. Ten years ago MGE used a similar process to develop their Energy 2015 Plan, which eliminated coal at their downtown Madison power plant, increased their renewable power from wind by almost twelve times, and reduced their carbon emissions significantly since 2005.

5. New Business

5.a. Introduction of new member

- Kim Warkentin introduced herself. She has been actively involved in the Quarry Hill Neighborhood Association, and she served as a Fitchburg representative on the former Regional Transit Authority. She is also the youth education coordinator for Wisconsin Land + Water (formerly Wisconsin Land and Water Conservation Association).

5.b. MG&E's Charge to Fitchburg for Street Lamps Electricity – LED Lights

- Fitchburg realizes a 12% cost savings for unmetered MGE-owned street lamps that have been converted to LED. Fitchburg pays actual energy costs for metered lights.
- Roughly 80% of street lights in Fitchburg are unmetered and 20% are metered.
- Fitchburg pays for unmetered, MGE-owned street lamps whether lights are working or non-working.
- Sherry Gruder recommended evaluating bulk purchasing and contracting through the State Energy Office for converting street lights to LED. Focus on Energy may be able to facilitate bulk purchasing with developers and multi-unit property owners as well.
- **Action items:**
 - **Erika will check with Holly Powell on**
 - **1) LED conversion strategies following Holly's conference**
 - **2) how MGE determines Fitchburg's bill for MGE-owned street lights.**

- **Erika will follow up with Sherrie Gruder on bulk purchasing opportunities through the State Energy Office**

5.c. Focus on Energy – Solar Grants

- Erika reported that Focus on Energy will not be offering a second round of grants in 2015 for renewable projects under the Renewable Energy Competitive Incentive Program (RECIP).
- Sherrie Gruder suggested considering a third-party solar model, which Monona installed in 2014, where a private-sector solar company leases space from a municipality for a period of time, pays for the upfront capital costs of a solar installation and then reverts ownership to the municipality after 6-8 years. Federal tax credits of ~ 30% expire at the end of 2016; so planning for this type of project would need to be underway by early September 2015 in order for the installation to be completed before the tax credits expire.
- Community solar is another option to explore.
- **Action item:**
 - **Erika will follow up with Sherrie Gruder to find out more details about these solar options, including cost and timeline.**

5.d. Eco-Municipality discussion

- Sherrie Gruder provided a quick overview of The Natural Step (TNS) framework.
- RCC members agreed that next step should be to form a Task Force (made up of business, agriculture, residents, representatives of underserved populations, city leaders and key staff) to begin a community dialogue on defining a vision for a sustainable Fitchburg and how to achieve it. Tentative timeline:
 - Summer recruitment of Task Force members with four meetings in the Fall, assuming funds are available.
 - Present resolution to Council to adopt TNS. Need to provide benefits, cost-savings and case studies.
 - Train City staff (6 meetings over 6 months, with group work on projects in-between)
 - Facilitate City staff in integrating TNS framework
 - Present results of projects
- Following step would be to present a resolution for Council to adopt
- UW-Extension can train department heads, interested elected officials and key staff who can in turn train all remaining staff. UWEX can help mentor project teams through the process.
- Tony suggested an informational presentation to a meeting of the whole Council to introduce the idea and solicit feedback.
- Tentative Operating Budget information requested by Mayor Arnold:
 - **2015** - \$2,400 – UW-Extension – Process design and facilitation services for four Task Force meetings.
 - **2016** - ~\$16,000-\$17,000 – UW-Extension Sustainable Designer – Train city staff and elected officials in understanding and using TNS, integrate TNS into city operations, build capacity in designated staff for leadership

and subsequent training of all city staff, mentor and facilitate project teams using TNS (six meetings over six months), coach staff on design, implementation and reporting measurable results on projects.

- **2016** - ~\$2,300 – Dane County UW-Extension to assist with Community Study Circle facilitation.
- **2016** - TBD – UW-Extension – two additional Task Force meetings.
- **Action item:**
 - **Chris and Tony will discuss with Mayor Arnold.**

- The RCC Summer Event will be held at the Boys & Girls Club on Thursday, July 30th from 10:00-11:30 a.m., focusing on fun events to increase awareness of recycling
- The tentative plan is to break out in three groups of 20 students (ages 9-13) and rotate them through three stations. Tentative focus is:
 - 1) Watch and discuss a video about the reasons to recycle and display items that are made out of recyclable materials;
 - 2) Decorate reusable grocery bags;
 - 3) Conduct a facility and trash audit to identify what is recyclable.
- Erika mentioned that the Boys & Girls Club invited us back to train staff on recycling this Fall.

● Other initiative

- Ryan Fralish is leading an effort to reduce plastic bag use and improve reuse and recycling. He is evaluating the use of a small utility-type flag to secure plastic bags emptied after yard waste collection.

Any waste they receive will be placed in the landfill until the new facility is open in January. Rick mentioned there are other interim recycling options for C&D waste including Pellitteri and Royal. Felipe and Erika will promote these changes on our website.

- Erika created a utility bill stuffer focusing on lawn care and water conservation for June bills.

THE OVERRIDING “GOAL” OF PUBLIC OPEN SPACE = OUTDOOR RECREATION

OUTDOOR RECREATION can take a lot of different forms and uses. “Conventional’ forms and uses include basketball/volleyball courts, baseball/softball diamonds, and play equipment.....these conventional forms and uses will always have a place in public open space. A. **SOCIABLE** (Think: People)



“What attracts people most, it would appear, is other people.” – William Whyte

B. **SOLITUDE** (Think: Nature)



Solitude can include people....it’s more about surrounding environment and uses.

C. **SEAMS** (Think: Transportation Corridors and Linkages)



Trails from home to “work” places (jobs, schools, etc.).....trails from home to “errand” places (shopping centers, etc.)....and trails from home to “play” places (parks, restaurants, etc.).

A. SOCIABLE – What elements are needed to achieve?

- I. ENVIRONMENT – Shelters/pavilions, amphitheaters, food/drink/vending services and facilities;
 - II. USES/ACTIVITIES – Festivals, concerts, contests/races, movie nights, “teaching” garden, farmers market pavilion, German beer garden;

Last week Tony Hartmann and I met with Neil Howell, energy advisor and Fitchburg contact for Focus on Energy's Agriculture, Schools and Government Program. Please find a summary of available 2015 incentives along with recommendations on next steps.

Design Assistance Program (Fire Stations)

The Design Assistance Program provides design professionals, builders, developers and building owners with energy-saving options for the design of major renovation projects or new buildings over 5000 square feet. The program also offers incentives to design teams and to building owners, which can be used to reduce the upfront cost of high efficiency measures that exceed Wisconsin energy code requirements.

The Design Assistance Program is managed by a Minnesota contractor. To begin the process, we need to complete an online application ([enrollment wizard](#)). If we don't get accepted into the Design Assistance Program, we should contact Neil Howell for more information on other FOE incentives; we can also apply for incentives through both programs.

Recommendation: complete online application and contact Neil Howell to evaluate additional incentives

Retro-commissioning (Library, Community Center, City Hall)

The City is eligible for FOE incentive grants on *remaining* retro-commissioning projects including the Community Center condenser/AHU replacement project. (Air handlers and condensers are considered custom incentives and require FOE review to determine

incentive levels. Custom incentive levels are calculated on an estimated first-year energy savings associated with a project/technology.) We should contact Neil Howell to evaluate eligibility and begin [enrollment application](#). It is not too late in the project to apply for incentives. Neil will review our retro-commission audit. Unfortunately, incentives for LED streetlight conversion are ending on Dec. 15, 2015, and all lamps must be purchased AND installed in 2015. This year's incentives provide about \$40 per approved fixture, a 6% savings per fixture when the cost of purchasing and installing the fixture is taking into account. While there are no FOE street lights incentives planned for 2016, I will continue to monitor future incentives.

FOE will be starting up a revolving loan fund for 2015-16 that will continue to offer funding for renewable projects. The details on the loan fund are yet to be announced. Design Assistance Program (Fire Stations)

The Design Assistance Program provides design professionals, builders, developers and building owners with energy-saving options for the design of major renovation projects or new buildings over 5000 square feet. The program also offers incentives to design teams and to building owners, which can be used to reduce the upfront cost of high efficiency measures that exceed Wisconsin energy code requirements.

The Design Assistance Program is managed by a Minnesota contractor. To begin the process, we need to complete an online application ([enrollment wizard](#)). If we don't get accepted into the Design Assistance Program, we should contact Neil Howell for more information on other FOE incentives; we can also apply for incentives through both programs.

Recommendation: complete online application and contact Neil Howell to evaluate additional incentives

Retro-commissioning (Library, Community Center, City Hall)

The City is eligible for FOE incentive grants on *remaining* retro-commissioning projects including the Community Center condenser/AHU replacement project. (Air handlers and condensers are considered custom incentives and require FOE review to determine

incentive levels. Custom incentive levels are calculated on an estimated first-year energy savings associated with a project/technology.) We should contact Neil Howell to evaluate eligibility and begin [enrollment application](#). It is not too late in the project to apply for incentives. Neil will review our retro-commission audit. 1. **#1 – MZU-variable volume upgrade** – This item will be addressed in the air handler replacement in fall 2015. Kevin will provide recommendation to JDR Engineering to incorporate into their project design.
2. **#3-5 – Condenser replacements** – Replace condensers with minimum EER of 13. EER of 16 would be ideal if there is enough space and budget.
