**- NOTICE TO DOG/CAT OWNERS -**

**Stats. 95.21(10) PENALTIES.** (a) Failure to obtain rabies vaccination. An owner who fails to have a dog vaccinated against rabies as required under sub. (2)(a) may be required to forfeit not less than \$50.00 nor more than \$100.00.

**Stats. 174.05 (5)** The City of Fitchburg, will assess a late fee of \$5.00 from every owner of a dog 5 months of age or over, if the owner failed to obtain a license prior to April 1 of each year, or within 30 days of acquiring ownership of a licensable dog or if the owner failed to obtain a license on or before the dog reached licensable age.

**95.21 (2) RABIES VACCINATION REQUIREMENT FOR DOGS.** (a) The owner of a dog shall have the dog vaccinated against rabies by a veterinarian within 30 days after the dog reaches 4 months of age and revaccinated within one year after the initial vaccination... The owner of a dog shall have the dog revaccinated against rabies by a veterinarian before the date the immunization expires as stated on the certificate of vaccination or, if no date is specified, within 3 years after the previous vaccination. Cats: Evidence of rabies vaccination is required.
