APPLICANT MUST FILL IN SHADED AREA	Any person desiring to occupy or obstruct any right-of-way for any reason other than construction excavation, or similar acts described in Fitchburg Code, Chapter 27 shall apply for a temporary occupancy permit. In consideration of being permitted to make such occupation, I hereby agree that I will faithfully comply with the terms of this permit, including special provisions and conditions listed below or attached hereto, and any and all plans, details or notes attached hereto and made a part thereof; that I will comply with all applicable statutes, ordinances, rules, and regulation of the State of Wisconsin and the City of Fitchburg; that I will leave the street, sidewalk, alley or terrace in as good or better condition than existing when the work was commenced; that all restoration on the street, sidewalk, alley or terrace affected by my action upon this permit shall be completed within ten (10) calendar days of the closing of the occupation; that I agree this permit may be voided by the Director of Public Works if the work is not started within a reasonable length of time after the above stated starting date; and that I will comply with Chapter 30, article II of the Fitchburg General Ordinances; Erosion Control and Stormwater Management.

PERMIT CONDITIONS:

- 1) The owner or representative shall notify the Public Works Dept., Zach Treb. at 608-206-3109 a minimum of 48 hours prior to beginning any work in public ROW
- 2) Per Fitchburg Code Sec. 70-145 (article V), vehicles over 10,000 lbs. gross weight shall use curb blocking with 4"x4" wood blocking when mounting or crossing curb and gutter, specifically permitted in writing by Department. Gravel, stone, and/or soil curb ramping is prohibited.
- 3) This permit is valid for a period of 30 days from the date of approval unless otherwise noted.
- 4) Any approved or authorized objects placed in the street must have orange construction cones marking all corners.
- 5) Any necessary repairs shall conform to the City of Fitchburg latest edition Standard Specifications. <http://www.fitchburgwi.gov/DocumentCenter/View/10074>

SPECIAL PROVISIONS:

- 1) No road closings, sidewalk or bike paths obstructions will be permitted without permission of the Director of Public Works and a traffic control plan.
- 2) Advanced warning signs must be placed to meet MUTCD standards including sidewalk and bike path closed signs placed with advance warning at all access locations.
- 3) All restoration work must be completed within 10 days of project completion.
